CLAUDIO LOMNITZ is Professor of Anthropology at Columbia University, where he works on the history, politics, and culture of Latin America, particularly Mexico. He is the author of *Death and the Idea of Mexico* (Zone Books, 2005), a political and cultural history of death in Mexico from the sixteenth to the twenty-first centuries, and *Deep Mexico, Silent Mexico: An Anthropology of Nationalism* (University of Minnesota Press, 2001).

SUE ZEMKA is Associate Professor of English at the University of Colorado, Boulder. She specializes in nineteenth-century British literature and the history of the novel. She is currently writing a book on the representation of moments in nineteenth-century novels.

JAN PLAMPER is a historian of Russia and a Dilthey Fellow at the Center for the History of Emotions, Max Planck Institute for Human Development, Berlin. He is co-editor of *Personality Cults in Stalinism* (2004); author of *Alkhimiia vlasti: Kul't Stalina v izobrazitel'nom iskusstve* (2010, forthcoming in English as *The Stalin Cult: A Study in the Alchemy of Power*); and co-editor, with Benjamin Lazier, of a forthcoming volume on fear. His current projects include a book-length introduction to the history of emotions and a monograph on the history of fear among Russian soldiers.

BENJAMIN LAZIER is Associate Professor of History and Humanities at Reed College and the author of *God Interrupted: Heresy and the European Imagination Between the World Wars* (Princeton University Press, 2008).

RUTH LEYS is Henry Wiesenfeld Professor of Humanities at Johns Hopkins University. Recent books by her include *Trauma: A Genealogy* (Chicago University Press, 2000) and *From Guilt to Shame: Auschwitz and After* (Princeton University Press, 2007). She is presently writing a book on the history of theoretical and experimental approaches to the emotions from the post-World War II period to the present and on the recent turn to affect in the humanities and social sciences.

ADAM LOWENSTEIN is Associate Professor of English and Film Studies at the University of Pittsburgh. He is the author of *Shocking Representation: Historical Trauma, National Cinema, and the Modern Horror Film* (Columbia University Press, 2005) and is currently writing a book on the intersections between cinematic spectatorship, surrealism, and the age of new media.

HAROLD JAMES is Professor of History and International Affairs at Princeton University and Marie Curie Professor of History at the European University Institute, Florence. He is the author of *The End of Globalization* (Harvard University Press, 2001) and *The Creation and Destruction of Value* (Harvard University Press, 2009).
