She is the author of *Tracking the Banished Immortal: The Poetry of Li Bo and Its Critical Reception* (Honolulu, 2003) and is currently at work on a book tentatively titled *Coming to Our Senses: Locating the Subject in Traditional Chinese Literary Writing*.

CAROL GLUCK is the George Sansom Professor of History at Columbia University, specializing in the history of modern Japan. She is co-editor with Anna Tsing of *Words in Motion: Toward a Global Lexicon* (Durham, NC, 2009) and author of *Thinking with the Past: Japan and Modern History* (Berkeley, forthcoming).
